Explained trauma level 4 with more serious patients transported to Colorado Springs or Denver

Dawson Ranch Trail System: Mike Gromowski— Tezak set up no contingency for maintenance when subdivision formed. Mike took over the supervision of the trails in 2017 and continues to do a great job of surveying and organizing maintenance. Currently, Storm Trail needs complete reconstruction and is unsafe to use. Other trails need minor work. Budget allocation of \$3,000 given for use this year. Approximately \$6,000 is needed for Storm Trail. City has agreed to provide \$1,000. The question of a potential park was brought up. The idea will be presented to the City.

Covenant Compliance & Concerns: Architectural Approval Team— Good progress has been made in eliminating dead trees mostly caused by beetles. There are 43 issues open and 123 closed this year. Currently have 3 AA's and would like 5 to lessen the amount of work on everyone. Don't want to wear out our volunteers!!!

- HOA Member benefit with Twin Enviro Garbage Service All current customers who are members will
 automatically be on this program effective with your October 2023 billing cycle. There is no need to call unless
 you have a change to your service.
 - o For weekly pickup \$18.50 a month
 - o For bi-weekly pickup \$14.50 a month
 - Anyone who is age 62+, military, a first responder, or who works for the DOC will get an additional \$1/off of garbage service
 - They provide monthly or quarterly billing options
 - o Recycle pickup is \$16.98/month
- Updating the bylaws.
- Creating new database for our membership and perhaps moving to a lower cost accounting web system.
- Have one to three activities throughout the year that create opportunities for relationship building. 108
 neighbors attended the National Night Out
- Increase financial reserves.
